Adam Peaper with HWC Engineering gave a Comprehensive Plan update. He said since last August, they have conducted their entire first round of engagement that included an in person workshop at the library with 100 in attendance. That was also duplicated online with a survey that had 250 responses and an interacting mapping tool. There was a high school specific survey with over 50 responses. The interacting mapping tool received over 300 comments and over 2,000 reactions (like or dislike) to comments that were made.

Eleven stakeholder meetings were held with 75 participants with one including the high school student government. They were at the Farmer's Market and a high school football game.

Those were opportunities for input but mostly it was to inform people of the planning process and direct people to other online or in person engagement events. They took all of that information and started to synthesize key themes and preliminary goals that they have organized around the City's four pillars of public safety, structure, quality of life and economic development and they have added land use because of how important that is in the comprehensive plan. There is an important focus on reinvestment and redevelopment in the established areas in the community but also understanding and using new growth areas to diversify employment and housing opportunities. They drafted a future land use map and they are working through refinements with Mr. Nelson and his team. The next big step is what they call the Big Ideas Open House and that is coming up on February 29th at the library at 4:30 pm. In addition to the in person meeting, they will duplicate all the content of that meeting in an online survey and that will all go on the project website plangreenwood.com.

Mr. Campbell said the Council should have received the report from the last RDC meeting and to see him with any questions.

Ms. Betron said she lives in a neighborhood off of Honey Creek and she knows how bad the traffic is already and she asked if there were any thoughts about a roundabout going in. Mr. Tuohy said he doesn't know the answer to that question. He does know that there was a traffic study done and he suspects Mr. Nelson or his team may have more information about roadway improvements. Mr. Nelson said he doesn't have the exact answer either. He knows that the City engineer has reviewed the traffic study that came with this and they are supportive of this petition. He said typically a single developer would not fully construct a roundabout but it is something that they can look into. A lot of this will be analyzed during the site design. That is something he will follow up with her on. Ms. Betron said that would be great. She was thinking that if they plan to put a school there and have parents going in and out of there and then with people trying to make a left turn onto Honey Creek, it would be a mess. Mr. Nelson said the last time they saw this it was a couple months ago and at that time, the school had not confirmed that they would be moving there.

Mr. Campbell said he had discussed with the Mayor, the need for road improvements on Honey Creek which includes multiple roundabouts. He said if a school goes in there, it will be an elementary school.

Mr. Hopper asked if Lennar uses vinyl and Mr. Tuohy said no.

VI. New Business - Introductions of New Ordinances and Resolutions

ORDINANCE NO. 24-02 AN ORDINANCE APPROVING PARKING FEES FOR 520 S. MERIDIAN STREET PARKING GARAGE AS ADOPTED BY THE GREENWOOD BOARD OF PUBLIC WORKS AND SAFETY AND AMENDING GREENWOOD MUNICIPAL CODE (1993), CHAPTER 8, ARTICLE 4, TO ESTABLISH PARKING FEES (Sponsored by Gibson and Hill)

* Request to suspend the rule through second reading

Mr. Wright said that the parking garage is constructed and this is one of the final steps to get it opened. The final step is to get the rates set, get them programmed into the system and then test drive it before opening. He said the hope is before the end of the month they can get the rates approved. He explained the request to suspend the rules through second reading is because they can't charge fees if they open without this being passed.

Mr. Hopper said normally at a parking garage, if you lose your ticket, you pay X amount of dollars. He noticed that they aren't doing that. Mr. Hopper asked how the City is going to keep people from parking there a month and then coming back and saying they lost their ticket and now they only have to pay \$25. Mr. Wright said he assumes that if someone loses their ticket, they pay the maximum which would be \$25. Mr. Hopper said so in theory, he could park a car there for a year and say oh he lost my ticket and pay \$25. Mr. Hodson said there is a no overnight parking in City lots ordinance so the car would be towed if it were there overnight. Mr. Hopper asked how will distinguish a car parked there overnight from a guest that is staying at the apartments. More discussion took place between Mr. Hopper, Mr. Hodson and Ms. Gibson. Mr. Wright said that is something they can consult with Denison Parking on. Mr. Lekse asked if it is automated and Mr. Wright said it is but Denison will also have someone working on site during normal hours on weekdays. Mr. Moan said he would think that within Denison's system, there would be some redundancy to locate cars that have a ticket that hasn't been cashed in.

RESOLUTION NO. 24-01 A RESOLUTION AMENDING RESOLUTION NO. 21-07, A RESOLUTION DECLARING CERTAIN AREA WITHIN THE CITY OF GREENWOOD AN ECONOMIC REVITALIZATION AREA AND QUALIFYING CERTAIN REAL PROPERTY IMPROVEMENTS FOR TAX ABATEMENT AND SETTING THE TIME AND PLACE FOR A PUBLIC HEARING (GLA Properties, LLC (Four (4) Building Complex) (Sponsored by Hopper)

Adam Stone said late last fall, the sponsor of the rep approached the City and proactively let them know that the building size was going to change. The review committee made a suggestion that that should come before the Council. This is to revisit that and address some concerns and provide some information.

Alexis Sowder with KSM Location Advisors gave a presentation. See <u>link</u>.

Mr. Hopper asked if the new proposal means more truck traffic will come through that area as opposed to what would have been there before.

Justin Olashuk with Scannell Properties said they updated their traffic impact studies as part of their entitlements with planning staff. It fell within what was initially assumed in the traffic study that was done back in 2022.

Mr. Hopper said he is less enthused with the project as a whole than he was before. He asked if they could make any commitments if it comes under the \$8.5 million. Ms. Sowder said the abatement benefit is going to be less because of that. Mr. Hopper said the City would also get less. Ms. Sowder said the comp property they were using at 800 Commerce Parkway is almost an apples to apples comp. She said she understands what he's saying but between the land and the building, those have all been arrived at with comps. They aren't messing with the original SB-1 and they have the cost per square foot for land and building to get it to that \$12.5 million. Mr. Hodson said that Mr. Hopper was asking if they would commit to that \$12.5 figure if the assessor came in under that number. Ms. Sowder asked how would they commit to the \$12.5. Mr. Hodson said it would be a minimum payment. Mr. Stone said there are two options. One would be to agree upon a minimum assessed value. Secondly, there are opportunities when you get to the compliance aspect of this. At that point and time, there would be a fully assessed project that would be reported on the compliance form. That would provide the Council with the opportunity each year to re-evaluate this based on these commitments.

Mr. Olashuk said the proposed tenant is a long-term partner with Scannell and a long-term partner in Greenwood. With this being a build the suit user, they have the luxury of knowing their employment numbers and generally what investment they're making on a salary basis. The numbers listed are from April of 2022 and actually the project has grown in scale. They will be providing 163 jobs with average hourly salary of \$30, average salary position of \$82,000 per year and they are fully benefited as far as medical coverage. They would be executing a 15 year lease.

RESOLUTION 24-02 A RESOLUTION APPROVING CERTAIN AMENDMENTS TO THE EASTSIDE ECONOMIC DEVELOPMENT AREA (Pulte Del Webb Project) (Sponsored by Campbell and Hopper)

Mr. Stone spoke on behalf of the Redevelopment Commission. He said Res No. 24-02 and Res No. 24-03 have both received unanimous approval from the Greenwood RDC in the form of the declaratory resolutions. Both have also received unanimous approval at the Plan Commission. This is not the final step in either of these areas. The tentative date right now for public hearing would be the March 12th RDC meeting. They are preparing the final notices and tax impact statements for those. This is step three of a four step process.
