ORDINANCE NO. 24-35

AN ORDINANCE AMENDING THE 2024 SALARY ORDINANCE, COMMON COUNCIL ORDINANCE NO. 23-33, TO ADD AN ADDITIONAL ADMINISTRATIVE ASSISTANT POSITION IN THE FIRE DEPARTMENT FOR TRAINING PURPOSES

WHEREAS, the Greenwood Common Council passed Ordinance 23-33, "An Ordinance Fixing Salaries of Appointed Officers and Employees of the City of Greenwood, Indiana and City Utilities for the Year 2024" (the "2024 Salary Ordinance"), setting 2024 salaries for all employees and stating whether each position is exempt or non-exempt;

WHEREAS, there are currently two (2) full-time Administrative Assistant positions in the Fire Department and at the end of the year one of the Administrative Assistants in the Fire Department is leaving her position;

WHEREAS, the Fire Chief requests the addition of one full-time Administrative Assistant position in the Fire Department for the remainder of 2024 to provide the opportunity to train the successor Administrative Assistant and promote a smooth transition;

WHEREAS, on January 1, 2025 following the departure of one of the Administrative Assistants, staffing will return to two (2) Administrative Assistant positions in the Fire Department;

WHEREAS, the 2024 Salary Ordinance requires amendment to increase the number of Administrative Assistant positions in the Fire Department from two (2) to three (3);

WHEREAS, there exist unobligated funds currently in the Fire Department salary budget to compensate the additional Administrative Assistant position, and no additional appropriation is necessary to fund the amendment;

WHEREAS, the Assistant Administrative Assistant position is a non-exempt position eligible for overtime compensation under the Municipal Code,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, AS FOLLOWS:

Section 1. The 2024 Salary Ordinance, Common Council Ordinance No. 23-33, Section 2, Fire, is hereby amended to increase the number of Administrative Assistant positions in the Fire Department from two (2) to three (3), as follows:

Section 2. This Ordinance shall have no effect upon any other provisions of Ordinance No. 23-33 except as herein provided, and all other sections of Ordinance No. 23-33 not inconsistent herewith shall remain the same.

Section 3. The sections, paragraphs, sentences, clauses, phrases and words of this Ordinance are separable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Ordinance.

Section 4. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
