Mr. Andy Buroker attorney with Faegre Drinker Biddle and Reath, representing Ryan Homes, and also Mat Rousch with Ryan Home. This is just a general introduction for the concept and idea. We will be going back to the planning commission in a few weeks for a public hearing for the annexation. We are trying to get 81 acres annexed into the city of Greenwood. It's a voluntary annexation by H & I Amick Farm, LLC Property. Will follow the comprehensive plan with mixed commercial and mixed residential. Background on Ryan Homes, 4th largest home builders in the country, been constructing sought-after homes since 1948, in 15 active communities in Indiana, with 600 projected sales in 2024 and offering varies product types through the market. Presented an ariel map and slide show of proposed development. Question was asked about the placing a gas station, with regard to the residential homes, and that Mr. Goodin will be bringing up the close proximity of gas stations to residents. #### **Miscellaneous Business**

#### A. Public Comments

Mr. Mark Web, 405 Lea Way, asked council to rescind portions of the Walker Commons Development waivers which are 1. Unnecessary and 2. Violate the no vehicular connection zoning commitments placed upon this property. The traffic circulation portions of these waivers are unnecessary as the commitments control and therefore supersede the UDO ordinances regarding traffic circulation at the affected streets.

Control is established in the first paragraph of Section 10-06-01 of the UDO which states: "Whenever the applicable requirements of this ordinance or requirements of any other applicable governmental unit or agency are higher or more restrictive, the higher or more restrictive requirements shall control". If we break this down, we have 1., is the Common Council a higher unit of government than the Planning Department or Zoning Board? Yes, it is. 2., Is the No Vehicular Connection Commitment which closes three specific streets more restrictive than the broader UDO ordinances which only encourages connections between road networks? Yes, they are. 3., Therefore, with a higher unit of government and more restrictive requirement does the No Vehicular Connection Commitment control this situation? Yes, it does. 4., As the No Vehicular Connection Commitment controls, is a traffic circulation waiver required for the affected streets. No, it is not. Furthermore, the requirements necessary to obtain a traffic circulation waiver as specified in staff reports dated 8-26-24 and 10-14-24 violate the No Vehicular Connection Commitments of these parcels.

These requirements mandate a vehicular connection in the form of a right of way and road connection to Lea Lane, Green Valley Drive and Faith Street. For clarity, the UDO defines roads and streets as a "public way of purposes of vehicular travel". Therefor, the waiver requirements violate the no vehicular connection portion of the commitment and must be remove. In a staff report dated 8-26-24, the technical review committee attempts to bypass, revise or amend the no vehicular Connection commitments in the following manner. 1., bypass the commitment by speculation the future connections my someday be desirable and connections to the affected streets are justified, 2., revise the commitment by placing a temporary barrier between the connected streets, 3., amend the commitment by requiring a connection for emergency services. All of these have been considered and rejected by the Common Council as recorded in the minutes of the 02-05-24. As staff lacks the authority to bypass, revise or amend the commitments, the roads and rights of way proposed by staff must be removed for the Site Development Plan. As we have been considered and rejected by the Common Council as recorded in the minutes of 2-5-24, as staff lacks the authority to bypass, revise or amend the commitments, the road and rights of way proposed by staff must be removed for the Site Development plan. As we have documented tonight, there have been several failures by the Planning Zone and the Technical Review Committee in the Walker Development Site Plan. We therefore ask the Council to implement additional public oversight in this manner by requiring Common Council approval of this and other similar development project as provided in UDO Section 10-04-05 Site Development Plan Review Process. Inclosing, we ask the council to remove or compel the removal of the following, 1., traffic circulation waivers at Lea Lane, Green Valley Drive, and Faith Streets. 2., Removal of all roads and right of way connections to Lean Lane, Green Valley and Faith Streets. We also ask the council to add additional public oversight to the planning process by requiring final approval from the Common Council to plans submitted by the planning and zoning departments. Thank you.

Mr. Randy Goodin, 1157 Central Park Blvd., as it was mentioned to the developers, the distance from gas stations to residential is 400 feet, according to the ordinance. I am glad we were able to get that changed. But I asked the city to study the impact that gas stations have on residential areas, as well as any commercial business, whether a restaurant or shopping area. He explained that he is referring to the Circle K behind his residents He states that Circle K will say that they are in compliance. The lights from the Shell station by is home light up his back yard. They might not cast directly on his property, but he can see them. He asked to do a study to change the ordinance. Let's work together to come up with a solution that work for everyone. Thank you.
