ORDINANCE NO. 24-42

AN ORDINANCE PROVIDING FOR ADDITIONAL APPROPRIATIONS FROM THE AMERICAN RESCUE PLAN CORONAVIRUS LOCAL FISCAL RECOVERY FUND TO BUDGET CLASSIFICATION 431 (\$220,000.00) AND BUDGET CLASSIFICATION 441 (\$270,000.00)

WHEREAS, the City of Greenwood ("City") received its allocation of American Rescue Plan Act of 2021 Coronavirus Local Fiscal Recovery Funds (ARP Fund), and the U.S. Department of the Treasury final rule to implement the ARP Fund ("Final Rule") allows fund money to be used to provide government services to the extent of reduction in revenue presumed to have been due to the COVID-19 public health emergency;

WHEREAS, the Final Rule further provides that government services for which ARP Fund money may be spent includes costs for the performance of public improvement projects;

WHEREAS, the City Controller advises that funds are needed to cover the professional services costs of the Information Technology services contract with EXOS through the end of 2024 in the amount of Two Hundred Twenty Thousand Dollars and 00/100 (\$220,000.00);

WHEREAS, the City Controller further advises that funds are needed for right-of-way acquisition services for the Main Street Streetscape Project Phases 1 through 4 in the amount of Two Hundred Seventy Thousand Dollars and 00/100 (\$270,000.00);

WHEREAS, the City Controller has determined that the ARP Fund has a sufficient balance available to fund a portion of the professional services and requests an appropriation from the ARP Fund to ARP Fund budget classification Other Services and Charges 431-Professional Services, to cover the Information Technology services contract with EXOS through the end of 2024 in the amount of Two Hundred Twenty Thousand Dollars and 00/100 (\$220,000.00), and an appropriation from the ARP Fund to ARP Fund budget classification Capital Outlays – 441 Land, to cover the costs of the Main Street Streetscape Project Phases 1 through 4 in the amount of Two Hundred Seventy Thousand Dollars and 00/100 (\$270,000.00);

WHEREAS, the Common Council has determined that it is necessary and appropriate to make the additional appropriations and shall hold a public hearing in accordance with law,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1. For the expenses of the City of Greenwood, the following additional sums of money are hereby appropriated and ordered set apart out of the fund herein named and for the purposes herein specified subject to the laws governing the same:

Other Services and Charges – 431000 Professional Services	\$220,000.00
Capital Outlays – 441000 Land	\$270,000.00

Section 2. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.




