

GREENWOOD COMMON COUNCIL

ORDINANCE NO. 24-43

AN ORDINANCE PROVIDING FOR A TRANSFER OF APPROPRIATIONS FROM THE GENERAL FUND (\$110,470) TO BUDGET CLASSIFICATION 431000 FOR PROFESSIONAL SERVICES.

WHEREAS, the City Controller recommends a transfer of appropriations from the General Fund, account 411000, to the Other Services and Charges Fund, account 431000, to ensure funding for Information Technology services provided by EXOS;

WHEREAS, the City Controller has determined that the General Fund has a sufficient balance to fund the Information Technology services contract with EXOS;

WHEREAS, the City Controller requests a transfer of appropriation from the General Fund account 411000 – Salaries and Wages in the amount of One Hundred Ten Thousand Four Hundred and Seventy Dollars and 00/100 (\$110,470.00) to Budget Classification Other Services and Charges – 431000 Professional Services, to allow the City to fund the Informational Technology services contract with EXOS;

WHEREAS, the Common Council has determined that it is necessary and appropriate to make the requested transfer of appropriations,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1. For the expenses of the City of Greenwood, the following transfer of budgeted appropriations is hereby appropriated and ordered set apart out of the fund herein named and for the purposes herein specified subject to the laws governing the same:

<u>General FUND</u>	<u>Amount</u>
General Fund – 411000 Salaries and Wages	(\$110,470.00)
Other Services and Charges – 431000 Professional Services	\$110,470.00

Said sum is to be used for expenditures of the type and kind permitted by law.

Section 2. This Ordinance shall be in full force and effect from and after its passage and approval according to law.


