

GREENWOOD COMMON COUNCIL

ORDINANCE NO. 24-44

AN ORDINANCE TO AMEND THE STORMWATER MANAGEMENT ORDINANCE

incorporated within the Greenwood Municipal Code (1993), as a part of Chapter 9 and the relevant portions of Chapter 9 thereof, are hereby amended as set forth in this ordinance.

WHEREAS, the Greenwood Board of Directors of the Department of Stormwater Management ("Board") adopted Resolution 2024-05 on November 13, 2024 recommending that the current Greenwood Stormwater Management Ordinance be amended to address changes necessitated by the state's recent implementation of a new Construction Stormwater General Permit;

WHEREAS, the Board further recommends additional changes, including removal of the permit fee schedule from the ordinance to allow its incorporation within the City's separate fee schedule ordinance with other fees;

WHEREAS, the Greenwood Common Council has considered the recommendation of the Board,

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, THAT:

Section 1. Greenwood Common Council Ordinance No. 15-33, "An Ordinance Amending Chapter 9, Article 4 of the Greenwood Municipal Code to Add and Revise Stormwater Provision", incorporated within the Greenwood Municipal Code (1993), as a part of Chapter 9 and the relevant portions of Chapter 9 thereof, are hereby amended as set forth in the redline text of Exhibit A, attached hereto and incorporated herein by reference.

Section 2. Ordinances not directly contradicted by the provisions of this ordinance and all provisions of the Municipal Code not specifically mentioned herein shall remain in full force and effect.

Section 3. The sections, paragraphs, sentences, clauses, phrases and words of this ordinance are separable, and if any word, phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this ordinance.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.




