ORDINANCE NO. 25-05

AN ORDINANCE AMENDING THE 2025 SALARY ORDINANCE, COMMON COUNCIL ORDINANCE NO. 24-27, TO DECREASE A MAINTENANCE LABORER POSITION AND ADD A MAINTENANCE LABORER/NON-DOT POSITION IN THE STORMWATER DEPARTMENT

WHEREAS, the Greenwood Common Council passed Ordinance 24-27, “An Ordinance Fixing Salaries of Appointed Officers and Employees of the City of Greenwood, Indiana and City Utilities for the Year 2025” (the “2025 Salary Ordinance”), setting 2025 salaries for all employees and stating whether each position is exempt or non-exempt;

WHEREAS, the Superintendent of the Department of Stormwater Management requests that the number of full-time Maintenance Laborer positions in the Department of Stormwater Management be decreased from three (3) to two (2), and that one (1) full-time Maintenance Laborer/Non-Department of Transportation (“Non-DOT”) position be added in the Department of Stormwater Management to provide for flexibility in staffing;

WHEREAS, the 2025 Salary Ordinance requires amendment to decrease the number of full-time Maintenance Laborer positions and add the Maintenance Laborer/Non-DOT position in the Department of Stormwater Management;

WHEREAS, there exist unobligated funds in the Department of Stormwater Management salary budget to compensate the two (2) full-time Maintenance Laborer and one (1) full-time Maintenance Laborer/Non-DOT positions, and no additional appropriation by the Common Council is necessary to fund the amendments;

WHEREAS, the full-time Maintenance Laborer/Non-DOT Position is a non-exempt position eligible for overtime compensation under the Municipal Code,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENWOOD, INDIANA, AS FOLLOWS:

Section 1. The 2025 Salary Ordinance, Common Council Ordinance No. 24-27, Section 2, Utility - Stormwater, is hereby amended to decrease the number of full-time Maintenance Laborer positions from three (3) to two (2), and to add the full-time position of Maintenance Laborer/Non-DOT in the Department of Stormwater Management, as follows:

Section 2. This Ordinance shall have no effect upon any other provisions of Ordinance No. 24-27 except as herein provided, and all other sections of Ordinance No. 24-27 not inconsistent herewith shall remain the same.

Section 3. The sections, paragraphs, sentences, clauses, phrases and words of this Ordinance are separable, and if any word, phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional, invalid or unenforceable by the valid judgment or decree of a Court of competent jurisdiction, such unconstitutionality, invalidity or unenforceability shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this Ordinance.

Section 4. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
