Job Purpose:	Responsible for maintaining and cleaning City Stormwater infrastructure, operate Vactor truck, repair infrastructure as needed to include catch basin rebuild, concrete work, operate small pieces of equipment and, inspection and assessment of city infrastructure.		

Duties and Responsibilities:

- Compliance with the Code of Conduct and Ethics as outlined in the Employee Handbook.
- Responsible for operating various trucks and equipment and hand tools in clearing and maintaining City streets and rights-of-ways.
- Assist in clearing City streets of snow and debris, hauls and spreads road materials and repairs streets and alleys.
- Install storm drains and pipes; repair street signs, guardrails and lights.
- Pour and forms concrete including sidewalks and curbs as necessary to finish job.
- Assist in excavating ditch and drainage sites establishing positive flow of water.
- Perform equipment and truck maintenance as needed.
- Assist with flagging and traffic control at City worksites.
- Utilize asset management software (Cityworks).
- Fill in for locator as needed.
- Perform other duties as assigned.

Job Requirements:

- **Education:** High School Diploma or GED equivalent.
- **Experience:** Three to five years' experience with street repairs, operating trucks and equipment and OSHA safety policies and procedures.
- **Skills and Abilities:** Able to operate various equipment including chain and pavement saws, welder, snow plow, bush hog, street sweeper and front-end loader. Ability to operate other equipment as necessary. Must possess valid Commercial Driver's License Class B, with airbrake endorsement, and a safe driving record.
- **Physical:** Capable of driving/sitting and standing/walking for long periods of time, lifting and carrying objects weighing up to 150lbs and operating various tools and equipment. Must be able to work extended hours as needed, which includes on call after normal working hours and/or weekends.
